# Safety Matters **Construction**

## Preventing Falls Due to Extreme Heat

Extreme heat creates many risks in construction. As an employee in this industry, not only should you be aware of illnesses caused by the heat, but you also need to be mindful of how high temperatures can cause physical and mental impairments that can lead to falls and know how to prevent this hazard.

### How Does Heat Impact Construction Workers?

The Centers for Disease Control and Prevention asserts that heat exposure increases the risk of workers experiencing a traumatic injury, such as a fall. This can be due to the following heat-related effects:

- Impaired thinking
- Dizziness and the reduced ability to maintain balance
- Slowed reaction time
- Muscle fatigue
- Cramping
- Slippery hands from sweat
- Reduced awareness of danger

Hot conditions can also lead to cloudy or foggy eyewear that can impact vision.

### Tips to Prevent Heat Illness and Related Falls

There are several ways you can reduce your risk of suffering a heat-related illness or impairment that could cause a fall. Strategies to consider include:

- Hydrate with water or electrolyte-rich

beverages before and during your shift. Avoid caffeinated drinks, which can cause dehydration.

- Take breaks in the shade, removing outer protective gear to help cool off. Your work and rest schedules should be adapted to the conditions, your individual characteristics and the nature of the job (e.g., 15 minutes of shaded rest for every 45 minutes of work).
- Dress for the weather by wearing loose, light-colored clothing made of breathable fabrics that do not create a safety hazard around equipment.
- Slowly build up to more strenuous work over a seven- to 14-day period to allow your body to acclimate to the hot conditions.
- Don't overexert yourself during periods of peak temperatures.

By being proactive and aware of the risks extreme heat presents, you can reduce the risks associated with extreme heat, including heat-related falls.



## **Industry News and Advocacy**

### **Trump White House Zeros Out SRFs In 2026 Budget**

**Expecting controversy, late Friday, May 2, the Trump Administration released its proposed FY2026 budget for the U.S. government. The proposal calls to cut both of the industry-critical Drinking Water and Clean Water State Revolving Funds by over 80%, with the proposal inaccurately claiming that the states could finance these projects and did not need federal government help.**

**NUCA immediately released a strong statement, pointing out that SRF funding is already inadequate and that states "simply will not be able to fill the funding gap." While Congress is ultimately responsible for passing a federal budget, the White House proposed cuts are another example of our industry being used as a political football at the expense of the nation's health and economy. Our 2025 Washington Summit was perfectly timed to remind our lawmakers that local water infrastructure is critical national infrastructure.**

**ASCE Report Card On Water Infrastructure: Needs Improvement The American Society for Civil Engineers (ASCE) released in April their quadrennial report card on America's infrastructure, giving the nation an improved grade of C, up from 2021's C-. However, drinking water's dismal grade of C- has not improved since the last report card, nor has wastewater's unchanged grade of D+ and stormwater's D. ASCE's report card remains a very timely reminder to policymakers and the American voter that the only way to build a better America is to deliver more resources for its construction.**

### **Independent Contractor Standard Will Not Be Enforced, Says USDOL**

**The U.S. Labor Department's Wage and Hour Division issued a memo to staff May 1 telling them not to enforce the Biden administration's independent contractor standard, and reverted enforcement resources back to the 2019 guidelines issued by the first Trump Administration. While the Biden era rule remains in effect, the change is specific to the department's enforcement priorities. The Trump USDOL said it is taking another look at the regulation but has not yet started the process to rescind it.**
